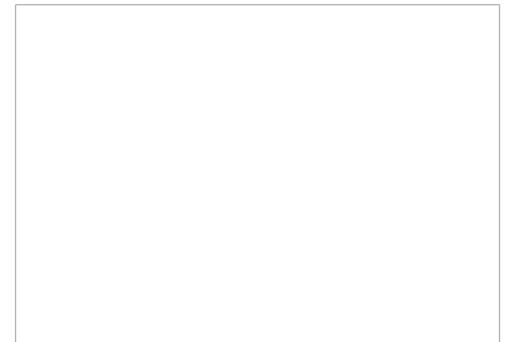

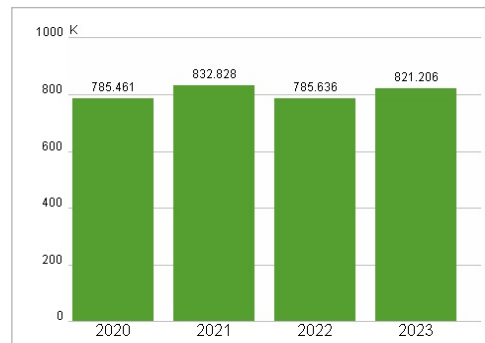

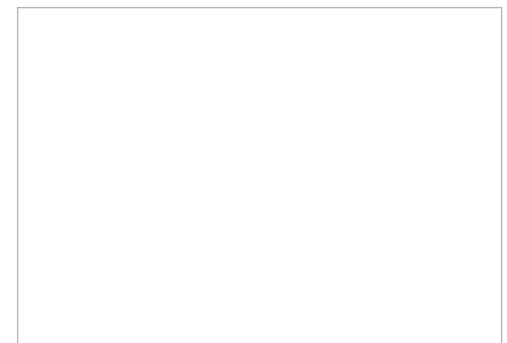
## Dividende je Aktie (USD)
