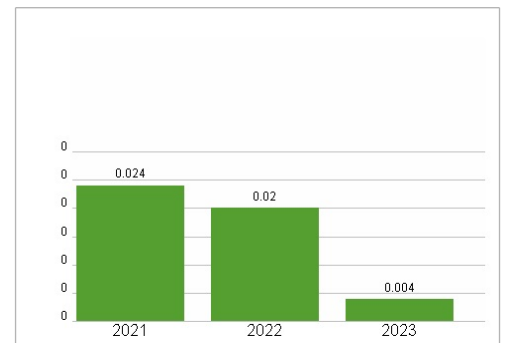

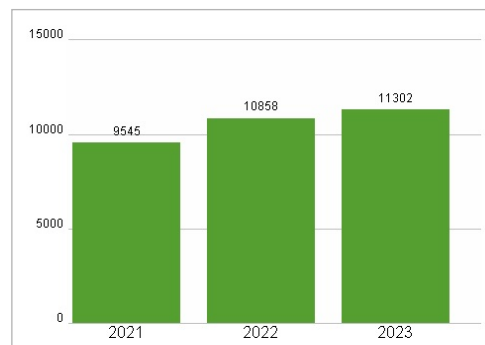

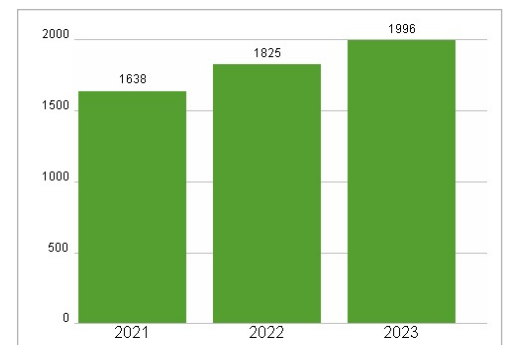
**Dividende je Aktie (GBP)**
